PLEASE TAKE NOTICE that upon the verified petition dated November 22, 2016, and the affidavit of Judge Fern A. Fisher, with accompanying exhibit annexed thereto, petitioners will move at the Motion Support Office, Room 130, 60 Centre Street, on January 4, 2017, at 9:30 o'clock in the forenoon, or as soon thereafter as counsel can be heard, for an order and judgment made pursuant to CPLR 5015(c):

1. vacating and setting aside the default judgments obtained or held by respondents as specified in the verified petition;
2. staying all marshals and/or sheriffs who hold executions under such judgments from executing to collect such judgments; and

This proceeding seeks a finding pursuant to CPLR 5015(c) that the defendants against
